for example, the agent may have a conflict of interest, such as a business relationship with a subcontractor or supplier of goods or services that could cause the agent to be biased in favor of those businesses. the agent may also have a conflict of interest in representing the author, such as (i) a financial interest in the outcome of the matter, or (ii) a business relationship with the other party

or parties to the matter. the agent may also have a conflict of interest in representing the author, such as a business relationship with the other party, a relationship that could cause the agent to be biased in favor of that party. for example, a subcontractor may not want the agent to represent the author in a dispute with the general contractor, because the subcontractor may believe that the general contractor will favor the agent and that the subcontractor will not be able to get a fair hearing from the agent. another example is a construction contract where a sub-contractor wants the agent to represent it in a dispute with the general contractor. the sub-contractor may not be willing to be represented by the general contractor. every author should have a good understanding of the publishing contract to which he or she is signing. not only can an author tailor the contract to his or her needs, but it is also a key document for the publisher. before you sign a contract, be sure to read it carefully. once you have read it, sign only those provisions that you understand and agree with, and try to negotiate for additional, favorable terms. authors should always be wary of signing a contract that they do not fully understand, particularly if it is a standard form contract that has been prepared by a publisher, as opposed to a contract prepared by an agent. publishers often add contract terms that are designed to protect them from liability, or they may include less favorable terms to authors who have an established reputation, and who may or may not be signed by an agent. 5ec8ef588b
